Contractual employees are **eligible to apply for internal competitions** while the contract is in-force. Eligibility continues until the date of termination or expiry of the contract. Upon termination or expiry, eligibility for internal competitions is discontinued unless, prior to accepting the contract, the employee had a pre-existing, uninterrupted employment relationship with the GNL public service. In this case, the contracted employee is granted eligibility for internal competitions for a period of **two (2) years following termination or expiry of the contract**.

Individuals on "**lay-off**" status from the public service retain eligibility to participate in **internal competitions for a period of two (2) years from the date of lay-off**.

Eligibility for internal competitions is immediately discontinued for applicants who sever the employment relationship with Government of Newfoundland and Labrador. This includes eligibility for any ongoing internal competitions for which an application has already been submitted.

Employees of external vendors providing contracted services to Government are not eligible to participate in internal competitions.
